

> Eligibility for Institutional Level Round

- Candidates who are previously <u>Registered with State CET Cell</u> but <u>NOT HOLDING ANY SEAT IN HAND</u> in previous round(s) of State Quota /All India Quota counselling are ELIGIBLE.
- Candidates having <u>JOINED STATUS in AIQ Round 2</u> are <u>NOT ELIGIBLE</u> for Institutional Level Round.
- Procedure of Institutional Round II for BAMS/ BHMS/ BUMS/ BPTH course at Private Unaided/ Minority Colleges for Academic Year 2021-22.
 - 1. Institutional Round II is only for Private Unaided/Minority Medical colleges and for seats remaining vacant after Institutional Level Round I.
 - 2. For admission during Institution level round the college / Institution should form a Committee of four members under Chairmanship of Dean/Principal to supervise the admission process.





- 4. It will be responsibility of the institute to verify and ascertain eligibility of the candidate as per respective Central Council rules before admitting the candidate even if name appear in ELIGIBLE list.
- 5. The list of ELIGIBLE candidates for the institutional round will be published on the website on 05/05/2022 as per schedule.
- 6. All eligible candidates registered with State CET Cell who have paid Rs.1000 can apply for admission on vacant Institutional Level Seats.
- 7. For institutional round eligible and interested candidates should approach to the Dean/Principal of the respective colleges within prescribed time and submit separate application for State Quota and institutional quota in person or any person. (One person can submit only one form. Form should be in hand written. No Xerox of the form / computer printout form is allowed. Application to college by registered speed post, courier or by e-mail is not allowed.) Such type of applications should not be submitted in the State CET Cell in person or email. Such type of applications submitted in State CET Cell will not be considered valid for any institutional level admission process.
- 8. Incomplete filled application form and application form without required/ essential Xerox copies shall be rejected.
- 9. For Vacant State Quota (85%) Seats: Please refer rule no 10.11.1. for rules of Institutional level round. For admission to vacant constitutional reserve seats refer rule no 9.4.1. of information brochure NEET UG-2021.
- 10. Any Candidate if Shifted from Private AYUSH & Allied course College to Govt/Corporation AYUSH & Allied College due to betterment or by Order of Competent Authority, such Candidate should be immediately relived if candidate desires so without any penalty.
- 11. At the time of admission during institutional round a candidate should submit all his original documents along with requisite fees in the form of DD/Cheque during prescribed time limit.
- 12. It is the sole responsibility of the candidate to submit all his original documents and requisite fees at the time of admission.
- 13. Admissions once taken in Institutional Level Round cannot be cancelled due to any reason.
- 14. All the candidates already admitted for MBBS/ BDS/ BAMS/ BHMS/ BUMS/ BPTH/ BOTH/ BASLP/ B P&O/ B.Sc. Nursing courses are NOT ELIGIBLE for institutional level round.
- 15. The admission process should be completed before Cut-off date prescribed for each course that is declared by respective Central Council and Competent Authority from time to time.
- 16. All the admissions are subject to approval of Admissions Regulating Authority after Cut-off date. The College should upload the information about admitted candidate in College Feedback Module of State CET Cell.
