This Certificate is Valid for a period of 3 years from the date of issue thereafter it will be automatically lapse.

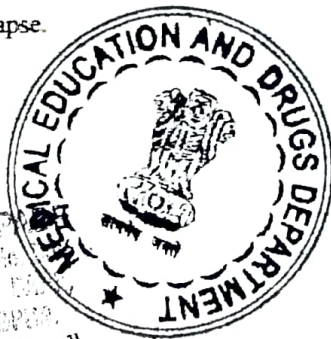

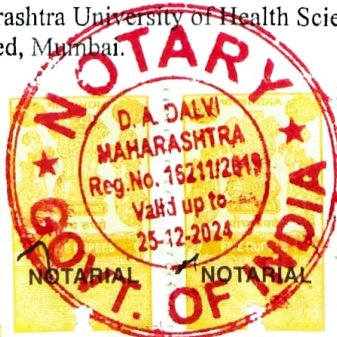
