Late Mrs. Housabai Homoeopathic Medical College and Hospital has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARBH has conducted Inspection on 19.07.2023 and shortfalls have been observed. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard requirements to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the shortfalls made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

A. Teaching Staff:


- a) In the meeting with teachers, it has been revealed that they are not getting their salary paid regularly. It is also reflected in the teachers acquittance roll. Not all teachers are found at a time in pay roll of any particular month.

B. Hospital:

- a) OPD - Though as per the record (maintained by Institute), average 241 patients/day, but on the day of Inspection only 08 patients were found registered till 11 am. But closing number was 230 cases at 5 pm, out of which in 08 cases, diagnosis and prescribed medicines were not matching with central register. The closing new case Registration number was 10866 but while cross checking case record, Registration number 10936 was also found and for 02 cases same Registration number was given i.e. 10834. This shows manipulation in OPD data.
- b) Pharmacy - Many medicines were not having proper labelling i.e. manufacturing date and batch number was not seen.
