Sir/Madam,

Late Mrs. Housabai Homoeopathic Medical College and Hospital has submitted an application for permission of 100 seats in BHMS course for the academic year 2026-27. The Medical Assessment and Rating Board (MARBH) has examined special application proforma submitted by the college followed by hearing on 23.04.2026. The Medical Assessment and Rating Board has examined the College to ascertain whether the college fulfils the Minimum Essential Standards as per the regulations in force.

1. Considering the observations during examination of special application proforma and hearing, Board has decided to issue **Permission to Late Mrs. Housabai Homoeopathic Medical College and Hospital for admission in BHMS course with intake capacity of 100 seats for the academic year 2026-27.**
2. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of UG seats shall be treated as All India Quota. Counselling for seats under all India quota shall be conducted by respective Counselling Authority of State/UT Government as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the state/UT.
3. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Board.
