Sir.

Late Mrs. Housabai Homoeopathic Medical College and Hospital has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 2025-26. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARBH has conducted inspections on 30.05.2025 & 31.05.2025, followed by hearing on 09.07.2025 and few shortcomings have been observed. The Medical Assessment and Rating Board has examined the College and with letter No. 4-7/ MARBH/NCH/2025-26(115-64)/6856 dated: 18.10.2025 decided to issue permission for continuing BHMS course with intake capacity of 70 seats and in compliance to the Ministry of AYUSH Letter No. R- 11014/1/2024-EP-II dated 24.06.2024, MARBH has reduced 29 seats. Therefore, MARBH decided to issue conditional permission to Late Mrs. Housabai Homoeopathic Medical College and Hospital with intake capacity of 51 seats (reduced from 100) for BHMS course for the academic year 2025-26.

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter No.4-MARBH/NCH/2025-26(115-64)/6856 dated: 18.10.2025 Late Mrs. Housabai Homoeopathic Medical College and Hospital has filed an appeal to the commission against the decision of MARBH vide their letter no. Letter No. HHMC/2025-26/172 dated: 27.10.2025. Commission has recommended to MARBH vide letter no. 30-5/2025-26/NCH-GR (107)/9064, dated: 06.11.2025 for the continuation of permission for 71 seats for 1st BHMS course to the Late Mrs. Housabai Homoeopathic Medical College and Hospital for the academic year 2025-26.

Accordingly, MARBH is granting Conditional Permission for 71 seats for BHMS Course for the academic year 2025-26 based on the following conditions:

College will submit the compliance report:

- i. Appointment of 01 UG teaching faculty.
- ii. Salary of teaching and non-teaching staff as per MES 2024.
- iii. NABL accreditation of hospital as soon as possible.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 71 UG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling

Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn in the subsequent year if college is found deficient in compliance to MES-2024 anytime during the academic year appeared.
